Do not rinse after application. **Cobweb Eliminator** may be applied indoor/outdoor on paint, metal, fiberglass, concrete and masonry. Reapply as often as needed. 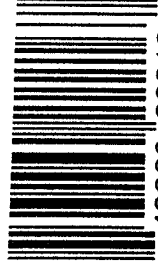
