

EYE: Pellets may cause slight eye irritation. Dusts may cause severe irritation with corneal injury. Effects may be slow to heal. When dissolving, the heat produced may cause more intense effects as well as thermal burns.

SKIN: Short single exposure not likely to cause significant skin irritation. Prolonged or repeated exposure may cause skin irritation, even a burn. May cause more severe response if skin is damp or if material is confined to skin. May cause more severe response if skin is abraded (scratched or cut). When dissolving, the heat produced may cause more intense effects as well as thermal burns. Not classified as corrosive according to DOT. A single prolonged exposure is not likely to result in
